# Chapter 2: Avaya Equinox® overview

The Avaya Equinox<sup>®</sup> client is a soft phone application that provides access to Unified Communications (UC) and Over the Top (OTT) services. You can access the Avaya Equinox<sup>®</sup> client on the following platforms:

- Mobile platforms:
  - Android: From a mobile phone, tablet, or an Avaya Vantage<sup>™</sup> device
  - iOS: From an iPad, iPhone, or iPod Touch
- Desktop platforms:
  - Mac
  - Windows

With the Avaya Equinox<sup>®</sup> client, you can use the following functionality:

- · Make point-to-point audio and video calls.
- Listen to your voice mail messages. You can view voice mail messages only on mobile clients by using Client Enablement Services.
- Join and host conference calls with moderator control features.
- Use point-to-point and conference call control functionality. You can also add participants to a conference.
- Answer calls, send all calls to voice mail, forward calls, and extend calls to your mobile phone if EC500 is configured.
- Share a portion of the screen, the entire display screen, an application, or a whiteboard while on a conference call on desktop clients.
- View a portion of the screen, the entire display screen, an application, or a whiteboard shared by another conference participant on mobile and desktop clients.
- · View your call history.
- Perform an enterprisewide search by using Avaya Aura<sup>®</sup> Device Services, Client Enablement Services, Avaya Cloud Services, or ActiveSync on mobile clients and Avaya Aura<sup>®</sup> Device Services, LDAP, or Avaya Cloud Services on desktop clients.
- Access your Avaya Aura<sup>®</sup> and local contacts.
- Access your Client Enablement Services favorite contacts on mobile clients.
- · Send instant messages.

- Capture photo, audio, and video files, and send generic file attachments in an IM conversation.

You can activate simultaneous ringing on your deskphone and device for a call that arrives on your deskphone.

#### Send All Calls

You can route all calls to your corporate voice mail number.

#### Join Active Call

You can join an active call on your deskphone by using your device.

## **Station Security**

You can use the station security code (SSC), which Avaya Equinox<sup>®</sup> appends to the EC500 code. Use of SSC improves security as it prevents other users from accessing functions associated with the station.

## **Key features of Client Enablement Services**

Client Enablement Services is an optional service that you can use with Avaya Equinox® and is available only on mobile clients.

#### Call Back

You can use the Call Back feature to control the originator phone that you want to use to call the destination number. The originator phone might be any phone such as a mobile phone, home phone, hotel room phone, or conference room phone. When you make a call by using the Call Back feature, you receive a call on the originator phone of your choice. After you answer the call, Avaya Equinox® dials the destination number.

### My Phones

You can use the My Phones feature to configure the phones associated with your account. Use the Ring Phones feature to configure the numbers that must ring for an incoming call. If you cannot answer an incoming call, Avaya Equinox® automatically sends the call to your office voice mail if voice mail is configured for your extension.

### One number

One number is a feature of both EC500 and Client Enablement Services. Calls on your office number are extended to your device for EC500 or to your ring phones for Client Enablement Services. All outbound calls using EC500 or Client Enablement Services display your enterprise caller ID irrespective of whether you make the call from your device or any other phone that you select by using Client Enablement Services.

Advantages of the Client Enablement Services version:

• The user, and not the administrator, can define the destinations.

- The user can choose which destinations to activate.
- The user can set the phone to ring up to 5 numbers simultaneously. EC500 only allows 1.

## **Availability**

You can use the Availability feature to set your current presence status. Client Enablement Services provides presence information by using Avaya Aura® Presence Services.



If the administrator provisions the VoIP service and Client Enablement Services, then Avaya Equinox® provides presence by using the VoIP service and not Client Enablement Services.

## **Contacts**

You can use the Contacts feature to search local and enterprise contacts. You can add enterprise contacts to your favorite contacts list.



If the administrator provisions Avaya Aura<sup>®</sup> Device Services and Client Enablement Services on mobile clients, Avaya Equinox<sup>®</sup> provides access to contacts and corporate directory search by using Avaya Aura<sup>®</sup> Device Services and not Client Enablement Services.

### Visual voice mail

You can view and listen to your voice mail messages.

## 24\*7 call logs

You can view, redial, and delete call logs associated with your Client Enablement Services account when you use Avaya Equinox® to log in to Client Enablement Services. The Client Enablement Services server maintains and records your logs even when you cannot connect to the server by using Avaya Equinox®. Avaya Equinox® downloads the updated logs when you log in successfully.

## **Device-specific login**

For security reasons, the administrator can restrict the use of Avaya Equinox<sup>®</sup> to a single device.

Every device has a unique device identifier (ID). When you log in to Avaya Equinox<sup>®</sup>, the Client Enablement Services server retrieves the device ID to authenticate you and prevent unauthorized use of Avaya Equinox<sup>®</sup>.

If the administrator groups your Client Enablement Services account in the **Restrict login to a specific device** group on the Client Enablement Services server, you can use Avaya Equinox® on only your device with your account. If you try to log in to your Client Enablement Services account in Avaya Equinox® on a device other than the device whose ID is associated with your account, you will have only four attempts. After four attempts, Avaya Equinox® removes the data from the application.

If you change devices, you must contact your administrator to reset the device ID associated with your account. Client Enablement Services retrieves your new device ID during a new login attempt.

If the administrator removes your account from the **Restrict login to a specific device** group, you can log in to Avaya Equinox<sup>®</sup> from any device by using your account.

## Key features of Avaya Aura® Device Services

Avaya Aura® Device Services is an optional service that you can use with Avaya Equinox® and is available from Avaya Aura® Release 7.0 onwards.

## User provisioning and configuration

A user must be provisioned on the LDAP server to use the Contact service.

The Dynamic Configuration service uses the automatic configuration feature of Avaya Equinox® clients to facilitate the configuration of client details. With this, the user can avoid manual configuration of the client.

The Web Deployment service publishes and deploys the UC client updates to the devices of the end users. The Web Deployment service supports only the Avaya Equinox® desktop clients.

#### Contacts

You can use the Contacts feature to search enterprise contacts across multiple LDAP directories. You can add enterprise contacts to your favorite contacts list.

Avaya Aura<sup>®</sup> Device Services consolidates contacts across multiple LDAPs and Session Manager (PPM). Contact merging is done in the client for local contacts and PPM contacts if they have the same email address.



### Note:

If the administrator provisions Avaya Aura® Device Services and Client Enablement Services on mobile clients, Avaya Equinox<sup>®</sup> provides access to contacts and corporate directory search by using Avaya Aura® Device Services and not Client Enablement Services.

## **Key features of the VolP service**

VoIP is an optional service for mobile clients if the user configures Client Enablement Services or EC500. For desktop clients, VoIP is a mandatory service to use with Avaya Equinox<sup>®</sup>.

### Remote worker support

You can connect to both enterprise and public Wi-Fi or cellular data by using a VPN client or Session Border Controller (SBC).

#### Support for VoIP calls

On mobile clients, you can connect to mobile data networks and Wi-Fi to make and receive VoIP calls. While on an active call, you can:

- Use the mute and unmute feature for audio and video calls.
- Open the keypad to use DTMF keys.
- · Make or receive another call.
- Transfer the active single call to another number.
- · Hold or unhold the call.

- Use the hands-free speaker on the device.
- Move the call to a paired Bluetooth headset.
- Make a conference call.
- · Join a call that has been started on another device.

### Multiple calls

You can make or handle multiple calls simultaneously.

### Send All Calls

You can route all calls to your corporate voice mail number.

## Simultaneous Ring

You can activate simultaneous ringing on your deskphone and device for a call that arrives on your deskphone.

### Call Forward

You can forward all calls to another telephone number of your choice.

## Call Forward Busy or Do Not Answer

You can forward all calls to another telephone number of your choice only when you are on another call or if you do not answer.

#### Presence status

You can use the Availability feature to set your current presence status. You can configure the application to send all incoming calls to voice mail when you set your presence status to "Do not disturb (DND)".



If the administrator provisions the VoIP service and Client Enablement Services, then Avaya Equinox® provides presence by using the VoIP service and not Client Enablement Services.

#### LDAP search

You can perform an LDAP search by using Microsoft ActiveSync if you have configured Microsoft Exchange on your mobile.

## Note:

For ActiveSync to work, the user must disable Avaya Aura® Device Services and Client Enablement Services.

#### Call transfer and conference

You can make a conference call or transfer an active call or an on-hold call.

### Multiple device access

You can register more than one SIP device on a single extension number. For example, you can have the same extension number on a deskphone and a device. If enabled, an incoming call on that extension number alerts all devices and you can answer the call from any device.

## Note:

Use MDA with TLS enabled on the Avaya Equinox® client and deskphone. If one client uses TLS and the other client uses TCP, the TLS client receives a call, but the TCP client does not receive the call.

Use the Multi Device Access (MDA) feature to enable or disable features configured for an extension from any MDA endpoint. For example, if you enable the Send All Calls feature, Avaya Equinox® enables the feature on all other MDA devices.

## **Enhanced call security**

If you enable Transport Layer Security (TLS) while using the VoIP service, Avaya Equinox® attempts to use Secure Real-time Transport Protocol (SRTP).

TLS is a protocol that ensures privacy between communicating applications and users on the Internet. SRTP provides enhanced security features for VoIP communications.

Whether Avaya Equinox<sup>®</sup> uses SRTP for a call depends on the system configuration and the capability of the devices involved in the call.

## **Key features of the Avaya Multimedia Messaging service**

Avaya Multimedia Messaging is an optional service that you can use with Avaya Equinox<sup>®</sup>.

## Instant messages

You can exchange text-based instant messages with users of Avaya Multimedia Messaging.

#### **Attachments**

You can receive an image, an audio or video recording, and generic attachments in an Instant Messaging (IM) conversation.

Only users with enhanced privileges can send generic attachments and use the built-in recording feature of Avaya Equinox® to attach audio, video, or image files.



### Note:

Desktop clients do not need enhanced privileges to send generic attachments.

#### **Active conversations**

You can view and participate in active conversations from multiple devices. You can also add multiple participants to a conversation.

### Name a group conversation

You can provide a subject name to a group conversation. Participants in that group can change the subject name of that particular session.

### Call participants

You can call one or more participants from an active conversation.

#### Archived or inactive conversations

You can search for archived or inactive conversations.

## **Key features of the Conferencing service**

Conferencing is an optional service that you can use with Avaya Equinox<sup>®</sup>.

### Conference calls

You can start an audio or video conference call and perform the following activities:

- · Add multiple participants.
- · Merge an active call to a conference call.
- Manage the entry and exit tones for participants.
- Record the conference. You can pause and resume the recording with Avaya Equinox<sup>®</sup>
  Conferencing.
- Manage the conference as a moderator or promote a participant to moderator.
- Lock the conference to prevent new participants from joining the call.
- Mute or unmute participants in a conference.
- Enable the Lecture mode. Participants can only listen to the moderator and cannot unmute the audio.
- Drop participants from the conference.
- Escalate point-to-point call to a conference.
- Merge point-to-point calls to create a conference.

## Avaya Equinox<sup>®</sup> Conferencing specific features

- · Use audio and video controls.
- Use remote user-based controls only for the moderator if the meeting is moderated.
- Use the Roster support.
- Use the Local user-based controls.
- · Use the Waiting Room support.
- · Use the Chat to room feature.
- Sign in to the Unified Portal inside the application without going to the browser.
- Join a meeting by using the OTT native client or the UC native client in presentation-only mode if you are using the UC or OTT deployment.
- In the Avaya Equinox® Conferencing UC or OTT deployment, the following Unified Conference Control Protocol (UCCP) features are available. UCCP is a web-based protocol. It is used by Conferencing clients to have conference control including roster, moderator commands, and user commands.
  - Knock on Door: The moderator can lock a conference. All participants who join after the conference is locked must request access to enter the conference. The moderator can accept or deny the request.
  - Raise hand: A participant can use this feature anytime during a conference call. The moderator can also raise or lower the user's hand.

- Conference encryption indicator: Avaya Equinox<sup>®</sup> displays the status of the audio or video media encryption in a conference. Streaming indicator is also supported as part of the Conference indicator feature.
- Conference passcode: A user must provide a passcode to join a conference.
- Dial-in information: A user must connect to a conference and get the dial-in information, which is general text similar to an outlook invitation.
- Far-End Camera Control (FECC): A participant in a conference can change the position and zoom of room system cameras such as XT endpoint.
- Recording failed event: All participants and the moderator receive a notification if the conference recording pauses, resumes, or stops.
- Add Terminal into Conference: The moderator can dial a terminal to add it to a conference.
- Video pinning: To make the participant's video visible, the user can pin the video in the required subframe of the incoming video.
- Select a participant as lecturer: The moderator selects and assigns a participant as a lecturer.
- Become moderator: A user can join a conference as a guest or signed user. In both cases, the user can become a moderator.
- Extend meeting: The moderator can extend a scheduled or instant meeting if the meeting policy has a specified end time.

## **Sharing information**

On desktop clients, you can share a part of the screen, application window, or the entire desktop with participants in a conference. On mobile clients, you can only view the content shared by other users.

You can perform BFCP sharing while on a P2P video call on Avaya Equinox® for Mac and Windows clients.

In the Avaya Equinox<sup>®</sup> Conferencing UC or OTT deployment, users can use BFCP to send and receive presentations during the conference meeting when virtual room is not enabled for WCS.

### **Annotations in shared content**

Web Collaboration Server (WCS) provides a range of tools for annotating shared content on desktop clients. You can add text, lines, and stamps to the shared content.

### Chat

In a conference, you can have a public chat with other participants or a private chat with an individual participant.

## New in this release

- Support for Single Sign-On (SSO) with Open Authorization (OAuth) and Security Assertion Mark-up Language (SAML).
  - Use this feature to integrate Avaya Equinox® SSO with a supported enterprise Identity Provider (IDP) solution for authentication including multi-factor authentication. Services included with the solution are Avaya Aura® Device Services Release 8.0 and later and the Avaya Multimedia Messaging service on Avaya Aura® Presence Services Release 8.1 and later.
  - A user can log in using OAuth and SAML and have an SSO experience for:
    - Voice service. Avaya Aura® Device Services provides the SIPSHA1 token.
    - Services provided by Avaya Aura® Device Services including auto-configuration, contacts, and enterprise search.
    - · Presence using SIP.
    - Avaya Multimedia Messaging service on Avaya Aura® Presence Services.
  - With Release 3.6 of Avaya Equinox® clients, the following services do not use the OAuth and SAML login flows. These are planned to be added in a future release:

  - Avaya Spaces login continues to use the Avaya Cloud Accounts login. Further integration is planned for a future release.
- Support for contact groups.

You can then initiate calls and instant messages to the groups. For example, you might have separate groups for your project team, subordinate team members, and response teams. The groups that you create are available across multiple devices.

# **Chapter 3: Interoperability**

## **Product compatibility**

To support Avaya Equinox<sup>®</sup>, you need the following main Avaya Aura<sup>®</sup> server elements and other server components:

- Avaya Equinox® Conferencing and Avaya Aura® Conferencing: For using the Conference (audio and video) and Web Collaboration features.
- Avaya Aura<sup>®</sup> Device Services: For user provisioning and configuration. Users can use the Contact service for contact management.
- Avaya Multimedia Messaging or Avaya Spaces: For using the instant messaging features.
- Avaya one-X<sup>®</sup> Client Enablement Services: For using the enhanced mobility capabilities.
- · Exchange Calendar
- Avaya Equinox<sup>®</sup> Media Server: For media processing and real-time collaboration. Required in the UC and OTT deployments of Avaya Equinox<sup>®</sup>.
- Avaya Aura<sup>®</sup> Communication Manager: For encrypted audio and encrypted or unencrypted video.
- Avaya Aura<sup>®</sup> System Manager
- Avaya Aura<sup>®</sup> Session Manager
- Avaya Aura<sup>®</sup> Presence Services: For using the presence features.
- Avaya Aura<sup>®</sup> Web Gateway: For providing browser-based WebRTC signaling and media.

You can optionally use Avaya Session Border Controller for Enterprise to provide a secure connection to users who work remotely and cannot connect to the enterprise network.

## Third-party product requirements

If users install multiple soft clients, then users might require Plantronics Hub. For call management using a Plantronics headset with Avaya Equinox<sup>®</sup> for Mac and Windows, Plantronics Hub must be of the latest version.

# **Chapter 4: Licensing requirements**

Suite user licenses include all the required licenses. You need licenses depending on the functionality and services that you want to access through Avaya Equinox<sup>®</sup>.

- EC500 features require EC500 licenses. This is included in Core and Power Suite.
- VoIP features require Mobile SIP licenses. This is included in Core and Power Suite.
- Avaya Multimedia Messaging features require Avaya Multimedia Messaging licenses.
- All video communications, including point-to-point video and video conferencing, require Communication Manager licenses. For only video conferencing, you need Avaya Aura<sup>®</sup> Conferencing or Avaya Equinox<sup>®</sup> Conferencing licenses. P2P video is included in Core and Power Suite. For UC and conferencing deployments, you need Avaya UC licenses.
- Client Enablement Services features require Client Enablement Services licenses. This is included in Core and Power Suite.
- Presence features require Presence Services licenses. This is included in Core and Power Suite.
- Remote worker features require Session Border Controller licenses. If Client Enablement Services is also required, you need Session Border Controller and Client Enablement Services licenses.
- Avaya Spaces features require Avaya Spaces licenses. License types include Basic, Plus, and Business.
- Avaya Equinox<sup>®</sup> VDI features require Avaya Equinox<sup>®</sup> VDI licenses. For each Avaya Equinox<sup>®</sup> VDI client, you need a separate license.

# **Chapter 5: Performance specifications**

## Redundancy and high availability

The administrator can configure more than one Session Manager server as part of the Avaya Aura® setup. If the setup includes more than one Session Manager server, the first Session Manager server is the primary server and the secondary Session Manager server is the High Availability server.

If the primary server fails or if Avaya Equinox® cannot connect to the primary server, Avaya Equinox® automatically fails over to the secondary Session Manager server to ensure service continuity. If failover occurs while on an active call, Avaya Equinox® preserves the speech path when possible. Some call features such as call hold might be unavailable for an active call during a failover.

Failover and failback occur as quickly as possible without user intervention.

## Dial plan specification

Most enterprise directories, including Active Directory, store telephone numbers in the standard E. 164 format. The E.164 format provides a unique description for each telephone number. Avaya Equinox® uses a dial plan to:

- Convert telephone numbers from the E.164 format to a sequence of numbers. The telephony server dials or uses these numbers for transformation of a mobile number or ring also number.
- Convert a sequence of numbers received from the telephony server to the E.164 format.

If you dial a number and the option to apply dial rules is enabled in Avaya Equinox<sup>®</sup>, Avaya Equinox<sup>®</sup> performs various checks on the dialed number before sending the modified number to the PBX. For more information about configuring the dial rules, see *Using Avaya Equinox*<sup>®</sup> for *Android, iOS, Mac, and Windows*.

Dialing translations take place in multiple locations in the solution stack. You must plan how these will work together. For example, Avaya Equinox® dialing rules, Session Manager ARS, Communication Manager, and Client Enablement Services.

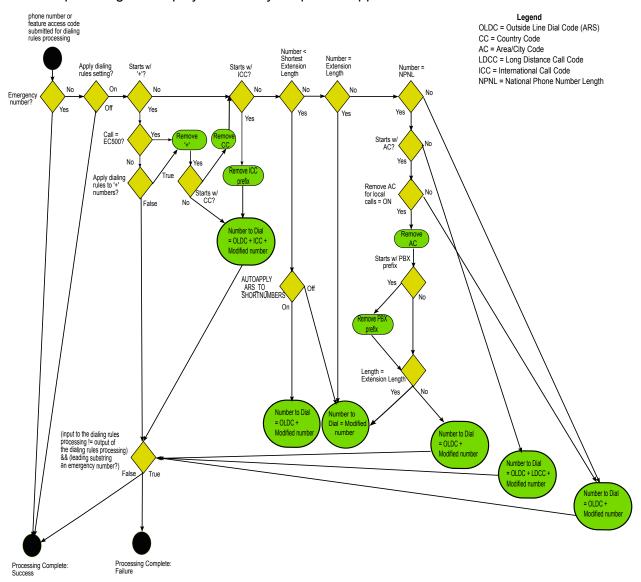
Do not use Avaya Equinox<sup>®</sup> to make emergency calls. Avaya recommends that you check the product documentation that accompanies your mobile device to learn about the emergency calling features available on your device.

#### Important:

You can use Avaya Equinox<sup>®</sup> on Avaya Vantage<sup>™</sup> to make emergency calls. For more information, see *Using Avaya Vantage*<sup>™</sup> *Connect*.

Dialing rules do not apply to:

- Emergency number dialed from Avaya Equinox<sup>®</sup>, provided the emergency number is configured on System Manager and the same is downloaded from PPM by the client.
- EC500 FNEs.

# **Chapter 6: Security**

#### Connections through a VPN or internal LAN

Avaya Equinox® supports connections through a VPN or internal LAN.

If you are joining an Avaya Equinox<sup>®</sup> conference by using a web client, Avaya Equinox<sup>®</sup> supports HTTPS connections.

#### Secure server connections

Avaya recommends the use of TLS to provide security for all network connections. Install a secure server certificate obtained from a certificate authority. Users of Avaya Equinox® can securely connect to network resources.

## Port assignments

To provide a secure communication channel for voice and instant messaging sessions, Avaya Equinox<sup>®</sup> requires TLS. Avaya Equinox<sup>®</sup> also supports Secure Real-Time Transport Protocol (SRTP) for both audio and video with Avaya Aura<sup>®</sup> dependencies.

#### Note:

- Avaya Equinox® does not support audio or video with Polycom SRTP devices.
- In Avaya Aura<sup>®</sup> Conferencing, ensure that the Encrypt RTCP parameter is *not* selected to maintain SRTP on a conference call. If you select this parameter, the SRTP call becomes an RTP call when the moderator adds participants to the conference.

# **Glossary**

Communication

Manager

A key component of Avaya Aura<sup>®</sup>. It delivers rich voice and video capabilities and provides a resilient, distributed network for media gateways and analog, digital, and IP-based communication devices. It includes advanced mobility features, built-in conference calling, contact

center applications and E911 capabilities.

**EC500** A feature that bridges calls received by the Avaya Aura<sup>®</sup> Communication

Manager server to any mobile phone, regardless of location or wireless

service provider.

Extension to Cellular access number

The phone number dialed to connect to the Avaya server that is running Communication Manager. The Extension to Cellular access number initiates the process of enabling or disabling Extension to Cellular or changing the station security code.

Feature name extension

An extension assigned to a feature within Communication Manager. The system administrator administers Feature name extension (FNE) to correspond to a feature access code that activates the feature.

FECC Far End Camera Control (FECC) is a feature of endpoint cameras, where

an endpoint in the call can remotely control the camera of another

endpoint in the call.

OTT Over the Top (OTT) deployment means that you can use the Avaya

Equinox<sup>®</sup> client in a non-Avaya Aura<sup>®</sup> environment as a conferencing

client for users that have a virtual room assigned to them.

Real-time Transport

Protocol

A network protocol that delivers audio and video over IP networks.

Secure Real-Time Transport Protocol An extension to Real-Time Transport Protocol (RTP) that incorporates enhanced security features. Like RTP, Secure RTP or SRTP is intended

mostly for VoIP communications.

Session Border Controller

A component that delivers security to a SIP-based Unified

Communications network.

**Session Manager** An enterprise SIP proxy registrar and router that is the core component

within the Avaya Aura® solution.

#### System Manager A common management framework for Avaya Aura® that provides

centralized management functions for provisioning and administration to reduce management complexity. System Manager can also function as a self-signed Root Certificate Authority (CA) or as an intermediate CA. System Manager enables the Simple Certificate Enrollment Protocol

(SCEP) application to sign certificates for Avaya deskphones.

UCCP Unified Conference Control Protocol (UCCP) is a web-based protocol. It

is used by Conferencing clients to have conference control including

roster, moderator commands, and user commands.
